- Explain any assistance needed from the District or Department.

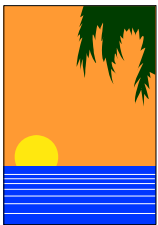

 6. Critic and Resolutions committee appointed.
 7. Distinguished guest introduced by Jack Pressey. 11 Past District Commanders in attendance.

 - e. Public Relations, Mark Foxworthy. Reported about a meeting he had. His report was very informative.

Motion by Mark Foxworthy, seconded by Kevin Kilkenny, to have the 5th District support the formation of an American Legion Riders unit within Napa and Solano Counties. Approved.
 - d. 23. Resolution Committee present Bread & Butter certificate to Rago Christopher Post 165. District also passed a repeat resolution in support of the "Veterans Remember Flag", by Jack London Post 489.
